Information held

The personal data we process will include the data set out below. We would not normally expect to process and "special category" sensitive data (e.g. health information, political or religious beliefs, sexual orientation etc.).

We will collect this data from you and would not expect to collect any data in relation to you from third parties.

Use of Data and Lawful basis of processing

We will process your personal data for the following purposes and on the bases for lawful processing set out below:-

Recipients of personal data

Retention period and criteria used to determine the retention period

Your rights

You may request that your personal data be erased, for example, where there is no compelling reason for its continued processing or where you withdraw consent. We will comply with your request unless we have another basis of processing justifying our retaining the data (for example a legal requirement or the defence of a legal claim).

You have some rights to ask us to restrict processing i.e. to block or supress processing where, for example, the data may be incorrect and whilst the accuracy is verified. We are permitted to store the data.

Your right to object
